On 12 March, Ibu Siti Rahayu officially opened the project "Adi Puri", an enterprise situated in the newly renovated "Big House" (the former residence of Bapak) at Wisma Subud in South Jakarta. Several hundred people attended the event from all parts of the world.



Adi Puri is a project of Yayasan Muhammad Subuh ("YMS"), a charitable foundation dedicated to preserving and promoting the life's work of Bapak Muhammad Subuh Sumohadiwidjojo. YMS will be assigning a professional company to manage the second-floor venue and to maintain the ground-floor gallery which utilizes audio-visual components to acquaint people with the life of Bapak.

The Big House was in great need of renovation and refurbishment; it had not been upgraded in decades. Unfortunately, due to the very short time-frame of the project, insufficient time was available to properly provide everyone with the project's business and marketing plans and we apologize for this. These plans are still being finalized and we will let everyone know when they are available for release.

MSF Board news – highlights of recent meeting

At recent meetings held in Jakarta & Central Kalimantan, the MSF board of trustees confirmed by majority vote the appointment of Olvia Reksodipoetro as Chair until the next World Congress, 2010.

The MSF Annual Report for 2007 was finalized and will be available for viewing on the MSF website next month.

New trustee sought

Prior to the meeting, Rusdi Bustillo submitted his resignation as MSF trustee. Nominations are sought for his replacement and may be made by national organizations through their Zone Representatives, MSF Trustees, and the World Subud Council.

The term of office for an MSF trustee is for 4 years. The candidate should have an understanding of the Subud organization and be able to work as a member of a team. The trustees are working trustees; the hours of work will vary. Areas of responsibility include investment, application assessments, public relations, fundraising, website maintenance, newsletters, liaising with MSF National Liaisons amongst others. Financial background/experience a definite plus.

Candidates need to be able to attend an annual board meeting, and an annual meeting with WSC, which generally coincide. No salary or compensation is paid to trustees, with the exception of airfares and accommodation for the annual meetings.

Candidate trustees should provide a CV and three references. A sub-committee consisting of members of the WSC and MSF trustees will review the CVs and contact the references. The WSA directors will base their final decision on the information received and guidance from testing carried out by the international helpers with the candidates, if present.
